Under Phil's leadership, Long Island Rail Road is delivering an historic \$6B capital program to modernize and expand its infrastructure, including Double Track, Main Line Expansion, East Side Access, Jamaica Capacity Improvements, new M9 fleet and Centralized Train Control.

Phil first joined the MTA in 2017 as the Chief Operating Officer where he spearheaded initiatives focused on modernizing transportation systems through innovative technologies. These include the development of new fare payment applications and testing new signaling systems. Phil also served as the Acting President for New York City Transit leading the early efforts of the Subway Action Plan.

Phil began his career in public service in 1983 at the New York State Department of Transportation as a Junior Engineer. He gained expertise working his way up through various groups from Structures, Bridge Inspection, Maintenance, Design and Construction.
