## Designations

CILTNA members are authorized to place letters after their names to indicate that they hold an official designation pursuant to the Royal Charter conferred on the Institute in 1926.

## Membership Grades

### Chartered Fellow

This is the highest grade of member. To be admitted, applicants must currently hold a CILT designation and have seven or more years of high-level management experience in the logistics, transportation, and/or the supply chain sector. The FCILT designation may also be awarded in exceptional circumstances to individuals who have made an outstanding contribution to the sector or who have a position of eminence in the field. Chartered Fellows may use the post-nominal letters FCILT after their name. They receive all the benefits of membership and may participate in all CILTNA events and vote at the annual general meeting. Annual fees are \$275 (plus applicable taxes).

### Chartered Member

This is the advanced level of membership. To be admitted, applicants must have completed a program of studies officially recognized by CILTNA and have at least five years of experience in logistics, transportation, and/or the supply chain sector, of which at least two years must be at a senior management level or equivalent as evaluated by the membership committee. Chartered members may use the post-nominal letters CMILT after their name. They receive all the benefits of membership and may participate in all CILTNA events and vote at the annual general meeting. Annual fees are \$194 (plus applicable taxes).

### Member

This is the working level of membership. To be admitted, applicants must have completed a program of studies officially recognized by CILTNA and/or have at least three years of junior management experience in logistics, transportation, and/or the supply chain sector. Members may use the post-nominal letters MILT after their name. They receive all the benefits of membership and may participate in all CILTNA events and vote at the annual general meeting. Annual fees \$146 (plus applicable taxes).

### Affiliate

This grade is for people interested in logistics, transportation, and/or the supply chain sector who do not yet meet the criteria for entry as a Member, or who wish to be associated with the Chartered Institute without becoming a member. They receive all the benefits of membership and may participate in all CILTNA events but not vote at the annual general meeting. Annual fees \$103 (plus applicable taxes).

### Student

This grade is for students enrolled in programs or courses in logistics, transportation, and/or supply chain management who do not yet meet the criteria for entry as Member but who wish to gain exposure to the

institute's activities and its networks with a view to a career in the sector and membership in the institute. They may participate in its events but do not vote at the annual general meeting. Annual fees are \$25 (plus applicable taxes).
