CONFERENCE SPEAKERS & MODERATORS



Emile Di Sanza FCILT, Director, CILTNA

Emile Di Sanza worked in the transportation field for nearly 30 years, holding various positions at Transport Canada, the National Transportation Agency and the Transportation Division of Statistics Canada. He retired from the Canadian public service in 2008.

As Director General, Marine Policy at Transport Canada (2002-2008), he was responsible for the development of economic policies and governance structures related to marine services, port authorities and the Seaway. In 2000-2001, he served as Executive Director for the Canada Transportation Act Review. Prior to that he was Director, Motor Carrier Policy, Transport Canada. Elected in 2008 to the Audit Body of the International Oil Pollution Compensation Funds, he served as chairman from 2011-2014. He joined the Chartered Institute of Logistics and Transport in 2012 and currently serves on the Board of Directors of the Ottawa Chapter.

He holds degrees from McGill University and McMaster University.



Arun Thangaraj, Deputy Minister of Transport

Arun Thangaraj was appointed Deputy Minister of Transport on February 20, 2023.

Before joining Transport Canada, Arun was the Associate Deputy Minister at Immigration, Refugees and Citizenship Canada, following two years as the Associate Deputy Minister at Transport Canada.

Before these roles, he was Assistant Deputy Minister and Chief Financial Officer at Global Affairs Canada and was the Deputy Chief Financial Officer at the former Canadian International Development Agency. He also brings experience and knowledge on transportation issues, from his time at the Canadian Transportation Agency from 2002 to 2011.

Arun received the Queen Diamond Jubilee Medal in 2013 for his contribution to the federal public service and to his community. He has served on various governance boards and is a sessional lecturer in the School of Public Administration at Carleton University.

Arun is a Chartered Professional Accountant and holds a Master of Arts in Public Administration from Carleton University, a Master of Business Administration from the University of Ottawa, and an Honours BA in Political Science from the University of Toronto.



Michael Keenan, Former Deputy Minister, Transport Canada

Michael Keenan served as a Deputy Minister in the Government of Canada for ten years, until he retired in January 2023 after a career spanning 35 years and seven departments.

Michael served as the Deputy Minister of Transport and, before that, the Associate Deputy Minister at Natural Resources Canada. He worked at Environment and Climate Change Canada, Agriculture and Agri-Food Canada, the Canada School of Public Service, the Privy Council Office and Finance Canada.

Michael has extensive experience in organizational leadership, digital transformation, regulatory modernization, Indigenous engagement, emergency management, international relations, and policy development in multiple disciplines, including economic, social, environment, safety and security.

He holds a Bachelor's degree from Saint Francis Xavier University and a Master's degree in Economics from Queen's University.



Matthew Stewart, Director, Economic Advisory, Deloitte

Matthew Stewart is a director in the Economics and Financial Advisory group at Deloitte Canada. He has almost 20 years of experience in economic forecasting, economic consulting, and international development.

Prior to joining Deloitte, Matthew was the director of the economics department at the Conference Board of Canada. He was responsible for all economic forecast publications, primarily overseeing the creation of economic analysis including industry forecasts and serving as the main media spokesperson.

Matthew has an MA in economics from McMaster University and a BA (Honours) in economics from the University of Western Ontario.



Dr. Meredith Lilly, Professor and Simon Reisman Chair in International Economic Policy, Carleton University

Meredith Lilly is a full Professor and Simon Reisman Chair in International Economic Policy at Carleton University's Norman Paterson School of International Affairs. Her research focuses on North American trade relations, Canada's trade diversification strategy, economic sanctions, and the use of research evidence in policy making. Before her appointment to Carleton in 2016, she served as Foreign Affairs and International Trade Advisor to Canadian Prime Minister Stephen Harper. She has also worked at the University of British Columbia Okanagan, and several federal government departments. She is a member of CD Howe Institute's International Economic Policy Council, an Advisory Board member for the Canadian Global Affairs Institute, and serves as the Academic Partner for Canada's delegation to the North American Forum. She engages regularly with foreign governments and diplomats, and is a frequent media commentator on North American trade issues.

Ms. McMillan is a seasoned supply chain professional and passionate business executive. Donald Roussel, former Associate ADM, TC and Founding Member, Intelligent Maritime Corridors International Council

As Senior Advisor, Mr. Roussel support stakeholders in the domains of, International Maritime rules and policies developments, Pilotage, Autonomous mode of transportation, Legislative & Regulatory Reform's.
Mr. Donald Roussel was appointed Associate Assistant Deputy Minister, Safety & Security, Transport Canada, in 2014. In January 2018, he was assigned as Senior Advisor to the Assistant Deputy Minister for Safety & Security, and reports to the Deputy Minister of Transport Canada.

As Associate Assistant Deputy Minister, Mr. Roussel was responsible for overseeing key aspects of Transport Canada's safety and security programs across the country, namely aviation, marine, rail, road, dangerous goods, and multi-modal transportation. Mr. Roussel was the Canadian representative at numerous national and international venues.
