British Airways penalized for violations of the APPR

The Canadian Transportation Agency (CTA) in mid 2025 issued a administrative monetary penalties totaling \$64,800 against British Airways for violations of the Air Passenger Protection Regulations (APPR). Between May 2, 2024, and October 9, 2024, British Airways committed 36 violations of subsections 5(2), 5(3) and 5(5) of the APPR, which include failing to inform passengers of the treatment applicable to them, the minimum compensation to which they may be entitled, and the recourse against the carrier available to them, including their recourse to the CTA. British Airways has until July 14, 2025, to request reviews before the Transportation Appeal Tribunal of Canada.

### (American Airlines penalized for violations of the APPR

The Canadian Transportation Agency (CTA) has issued administrative monetary penalties totalling \$52,200 against American Airlines for violations of the Air Passenger Protection Regulations (APPR). Between December 4, 2024, and April 11, 2025, American Airlines committed 34 violations of subsections 5(2), 5(3) and 5(5) of the APPR, which include failing to inform passengers of the assistance requirements (standards of treatment) applicable to them, the minimum compensation to which they may be entitled, and the recourse against the carrier available to them, including their recourse to the CTA. American Airlines has until August 11, 2025, to request reviews before the Transportation Appeal Tribunal of Canada.

# Porter Airlines finalizes sale and leaseback agreement for four Embraer E195-E2 aircraft

Porter Airlines has secured a sale and leaseback agreement for four Embraer E195-E2 aircraft to be delivered in 2025. The agreement was led by funds managed by affiliates of Fortress Investment Group (Fortress) and GOAL Aircraft Leasing. GOAL Aircraft Leasing is also serving as lessor manager for the aircraft. Ashland Place Finance is providing debt financing to Fortress and GOAL Aircraft Leasing for the transaction. Porter Airlines is the world's largest E195-E2 operator, and continues to expand its network across North America with its growing fleet. Forty-six E195-E2s have been delivered to Porter from a total of 75 confirmed orders, with an additional 25 remaining purchase options.

# April 2025 U.S. Airline Traffic Data Down 1.0% from the Same Month Last Year

U.S. airlines carried 80.4 million systemwide (domestic and international) scheduled service passengers in April 2025, according to the Bureau of Transportation Statistics (BTS). When adjusted for seasonality, April enplanements are down 2.2% from March and down 4.0% from the all-time high reached in December 2024. BTS reported 69.6 million domestic passengers and 10.8 million international passengers on U.S. airlines flights in April, not adjusting for seasonality. U.S. airline traffic reports are filed monthly with BTS. See the tables that accompany this release on the BTS website for summary data since 2016 and complete data since 2000.

# Air India crash report shows pilot confusion over engine switch movement

A preliminary report depicted confusion in the cockpit shortly before an Air India jetliner crashed and killed 260 people last month, after the plane's engine fuel cutoff switches flipped almost simultaneously and starved the engines of fuel. The Boeing 787 Dreamliner bound for London from the Indian city of Ahmedabad began to lose thrust and sink shortly after takeoff, according to the report on the world's deadliest aviation accident in a decade released on Saturday by Indian accident investigators. The report by India's Aircraft Accident Investigation Bureau (AAIB) about the June 12 crash raises fresh questions over the position of the critical engine fuel cutoff switches. Almost immediately after the plane lifted off the ground, closed-circuit TV footage showed a backup energy source called a ram air turbine had deployed, indicating a loss of power from the engines. In the flight's final moments, one pilot was heard on the cockpit voice recorder asking the other why he cut off the fuel. "The other pilot responded that he did not do so," the report said.

# Amid Air India probe, US FAA, Boeing notify fuel switch locks are safe, document, sources say

The U.S. Federal Aviation Administration and Boeing have privately issued notifications that the fuel switch locks on Boeing planes are safe, a document seen by Reuters showed and four sources with knowledge of the matter said. The FAA's Continued Airworthiness Notification on July 11 came after a preliminary report into Air India's Boeing 787-8 crash, which killed 260 people last month, raised questions over engine fuel cutoff switches. The FAA's notification to Civil Aviation Authorities, seen by Reuters, said: "although the fuel control switch design, including the locking feature, is similar on various Boeing airplane models, the FAA does not consider this issue to be an unsafe condition that would warrant an Airworthiness Directive on any Boeing airplane models, including the Model 787." When asked for comment, the FAA said it did not have anything to add beyond the notification.

# Air India CEO says investigation into Ahmedabad crash raises new questions

A preliminary investigation into the crash of an Air India passenger jet last month that killed 260 people raises additional questions about the incident and the investigation is far from over, Air India's CEO said in a memo on Monday. The preliminary investigation released by India's Aircraft Accident Investigation Bureau on Saturday depicted confusion in the cockpit shortly before the crash of the Boeing Dreamliner. In a staff memo reviewed by Reuters, Air India CEO Campbell Wilson said the report had "triggered a new round of speculation in the media ... Unsurprisingly, it provided both greater clarity and opened additional questions." He added: "The preliminary report identified no cause nor made any recommendations, so I urge everyone to avoid drawing premature conclusions as the investigation is far from over." The memo said the preliminary report found no mechanical or maintenance faults and that all required maintenance had been carried out.

According to the AAIB report, in the flight's final moments one pilot was heard on the cockpit voice recorder asking the other why he cut off the fuel. "The other pilot responded that he did not do so," the report said. It added that the plane's engine two fuel cutoff switches flipped almost simultaneously, but did not say how. The preliminary report suggested no immediate action for Boeing or GE, whose engines were fitted on the aircraft. ALPA India, which represents Indian pilots at the Montreal-based International Federation of Air Line Pilots' Associations, has rejected any presumption of pilot error and called for a "fair, fact-based inquiry". "The pilots had passed their mandatory pre-flight breathalyser and there were no observations pertaining to their medical status," Campbell said in his memo. Air India has come under heightened scrutiny on multiple fronts following the crash. On July 4, the European Union Aviation Safety Agency said it would investigate budget unit Air India Express, after a Reuters report revealed the airline failed to promptly replace engine parts on an Airbus A320 as mandated, and falsified records to indicate compliance. ### U.S. Cargo and Passenger Airlines Lost 872 Jobs in May 2025

U.S. airline industry (passenger and cargo airlines combined) employment decreased to 1,011,806 workers in May 2025, 872 (0.09%) less workers than in April 2025 (1,012,678). U.S. scheduled-service passenger airlines employed 549,931 workers in May 2025, or 55% of the industry-wide total. Passenger airlines gained 2,507 employees in May 2025. Spirit Air Lines led scheduled passenger carriers, adding 940 employees; American Airlines Inc. added 642, and United Air Lines Inc. added 621. U.S. cargo airlines employed 458,339 workers in May 2025, or 45% of the industry-wide total. Cargo carriers lost 2,629 employees in May 2025. FedEx, the leading air cargo employer, decreased employment by 2,630 jobs. See FedEx note for discontinuity in May 2024.

The aviation industry and the disabled community welcomed the publication of the report of the UK Aviation Accessibility Task and

Finish Group (AATFG) chaired by Baroness Tanni Grey-Thompson, on Wednesday 16 July. The AATFG was established by the UK government in 2024 and comprised key advocates from the disabled community, along with industry representatives. It was chaired by Baroness Tanni Grey-Thompson, a decorated Paralympian, and noted campaigner for people with disabilities. The report received some 168 suggestions which were categorized into recommendations covering issues such as: Training, information, and communication; Greater awareness, especially of non-visible impairments; Mobility aid design and handling, and better equipment for assisting passengers and handling personal mobility aids; Tailored services for improved delivery. Updated codes were identified as crucial to this, and the report acknowledges that an IATA taskforce is already looking at this; and CAA oversight to be reviewed and updated regularly.

UPDATE: CPKC denies KCS wrongdoing as rail union polls members on strike

A CPKC union is conducting a strike poll of members, claiming the railroad took advantage of a service crisis to make workplace job changes on the troubled Kansas City Southern network. The International Association of Sheet Metal, Air, Rail, and Transportation Workers (SMART-TD) Local 457's General Committee of Adjustment is polling members on a possible strike vote. General Chairman Samuel Habjan confirmed in a brief phone interview with FreightWaves late Saturday, July 12, 2025. The results of the poll are expected on July 13, 2025. Habjan would not speculate on the results of the poll, or the union's plans. An email signed by "union members local 781" and obtained by FreightWaves claimed that the railroad was using the service crisis to cut jobs and reduce some employees' working hours. The email said that CPKC was already facing a personnel shortage prior to a botched software changeover in May 2025 that caused a service crisis on the former KCS, aggravated by leaner operating practices and aggressive cost-cutting.

### VIA Rail Canada marks 'Ocean' anniversary

VIA Rail Canada is marking 120 years of continuous operation of the Ocean, Canada's oldest named passenger train, with ceremonies today (July 15, 2025) in Halifax. The event includes unveiling of restoration work at the Halifax station and public tours of the train's equipment. "This isn't just a train, it's a thread that's woven together families, communities, and memories for 120 years," Jonathan Goldbloom, chair of VIA's board of directors, said in a press release. "From soldiers leaving for war, to families reuniting at the holidays, to students heading off to start new chapters, The Ocean has carried them all. Today we honor that proud legacy and renew our commitment to keeping Canadians connected for generations to

come." The train between Halifax and Montreal was launched on July 3, 1904, as the Ocean Limited, a summer-only offering of the Intercolonial Railway of Canada, a Canadian National predecessor. The train retained its historic name when CN spun off its passenger operations into VIA Rail Canada in 1978. Long a daily train, it was reduced to three-day-a-week service from 1990 to 1994; restored to six-day operation until 2012, then returned to its current three-round-trip schedule in June 2012.

# Trump's Transportation Secretary Sean P. Duffy Pulls the Plug on \$4B for California High Speed Rail's Train to Nowhere

U.S. Transportation Secretary Sean P. Duffy on July 16, 2025 announced the Federal Railroad Administration terminated approximately \$4 billion in unspent federal funding for California's High Speed Rail Boondoggle. After 16 years and roughly \$15 billion spent, not one high speed track has been laid by the California High-Speed Rail Authority (CHSRA). The \$135 billion projected total cost of the

project could buy every San Francisco and LA resident nearly 200 roundtrip flights between the cities.

# BNSF, UP settle dispute over Salt Lake City intermodal service

BNSF Railway and Union Pacific settled their Salt Lake City trackage rights dispute on July 15, 2025 prior to a scheduled meeting with federal regulators. The deal allows BNSF to begin international intermodal service between Southern California ports and a new intermodal terminal on the Salt Lake Garfield & Western Railway. In a filing posted on the Surface Transportation Board website on July 16, 2025, the railroads asked the board to dismiss BNSF's request for an emergency order that would have required UP to accept the new trackage rights trains. "BNSF is proud to announce its new intermodal service between California and Salt Lake City. We have reached an agreement and service is currently underway," spokeswoman Kendall Sloan said in an email to Trains, "This new product offers the capacity to meet market demand and will grow as we move forward. We look forward to serving our customers with this expanded capacity and service." The filing did not provide details about the deal the two Class I railroads reached, including what route the trains will take or how many trains will operate per week.

# AAR: North American Rail Volume Up Through Week 28

North American carload and intermodal traffic for the first 28 weeks of 2025 (ending July 12) was up 2.9% from the prior-year period, according to the Association of American Railroads' (AAR) latest rail traffic report. While the United States and Canada both saw gains, Mexico experienced a loss. Eight of the 10 carload commodity groups posted an increase compared with the same week in 2024. They included coal, up 2,699 carloads, to 58,370; chemicals, up 1,931 carloads, to 32,599; and motor vehicles and parts, up 1,228 carloads, to 12,992. Commodity groups that posted decreases compared with the same week in 2024 were forest products, down 150 carloads, to 8,253; and metallic ores and metals, down 133 carloads, to 20,229. For the first 28 weeks of 2025, U.S. railroads reported cumulative volume of 6,133,836 carloads, up 2.6 percent from the same point last year; and 7,494,085 intermodal units, up 5.0 percent from last year. Total combined U.S. traffic for the first 28 weeks of 2025 was 13,627,921 carloads and intermodal units, an increase of 3.9 percent compared to last year. Canadian railroads reported 88,255 carloads for the week, up 1.6 percent, and 74,638 intermodal units, up 9.3 percent compared with the same week in 2024. For the first 28 weeks of 2025, Canadian railroads reported cumulative rail traffic volume of 4,556,986 carloads, containers and trailers, up 1.3 percent.

### Union Pacific, Norfolk Southern in merger talks: WSJ

In a move that could signal the final round of railroad mega-mergers, Union Pacific is in discussions to acquire Norfolk Southern, its smaller eastern rival, according to a published report. The talks are in the early stages, the Wall Street Journal reported late Thursday, July 17, 2025 after the close of markets, quoting anonymous sources. ### A Union Pacific Mega-Merger? Blockbuster News Reports Say the Wheels Are in Motion by Jay Shabat for Railroad Weekly

It's more than just an academic discussion now. A transcontinental railroad merger might actually happen. Last week, the news site Semafor reported that Union Pacific is working with the investment bank Morgan Stanley to explore the idea of buying an eastern railroad. One day later, the Wall Street Journal said merger discussions were underway with Norfolk Southern. The Journal report was clear, however, that "the talks are early stage and there are no guarantees they will result in any deal or receive regulatory signoff." The Associated Press later wrote that "the merger discussions began during the first quarter of this year, according to a person familiar with the talks." As of Sunday, Union Pacific had not made any public comments about the matter. The company did not respond to Railroad Weekly's inquiries.

Union Pacific, one might say, was born with a defect. When created after the Civil War, it ran westward to California from Omaha. Most of the nation's economic activity, however, was happening well east of Omaha. Western activity like agriculture and mining was heavily dependent on markets in Chicago in particular, a good 500 miles or so

east of Omaha. From its earliest days therefore, UP was contemplating how to build its network eastward. It never managed to extend east of Chicago, instead building a powerful network throughout the west via consolidation (following industry deregulation in 1980). UP bought the Missouri Pacific and Western Pacific in the 1980s, and the Chicago/Northwestern and Southern Pacific in the 1990s. As early as the 1960s, it was contemplating buying eastern peers like the ailing Pennsylvania Railroad.

Also in the 1990s, Burlington Northern and Santa Fe created BNSF, rivaling UP in western market power. The new BNSF then sought to leap ahead by striking a deal to merge with Canadian National in 1999. That deal, however, would fall apart amid heavy resistance, not least from UP. The angry pushback prompted the STB to impose a 15-month pause on new merger activity. One reason was shipper angst about severe service disruptions caused by UP's failure to smoothly integrate Southern Pacific. Norfolk Southern and CSX too, were having a difficult time digesting their split acquisition of Conrail. The STB feared a BNSF-CN merger might cause more heartache.

In the meantime, another consequential merger of the late 1990s—Canadian National's acquisition of the Illinois Central—set the industry on a new inward-looking path. The IC's Hunter Harrison, eventually rising to CEO at CN, spent the 2000s not focused on expanding through consolidation, but instead shrinking to lift profit margins. His strategy, called Precision Scheduled Railroading (PSR), proved enormously successful in financial terms. Harrison would later implement PSR at Canadian Pacific and again at CSX. UP itself adopted the strategy in 2018, hiring a new operating chief named Jim Vena—a Harrison protege—to help implement it. Unions hated PSR. Shippers hated PSR. But Wall Street loved it. Other railroads including Norfolk Southern and even to an extent BNSF were pressured to follow.

At some point though, there wasn't much more to cut. Class I railroad profit margins, having reached extremely high levels, stopped growing. In fact, they even slipped a bit. Consolidation again began to enter people's minds. CPKC, in 2021, outbid CN to acquire Kansas City Southern, creating CPKC. Notwithstanding some current operational messiness tied to IT issues, the CPKC merger has delivered reliable service, strong profits, lots of revenue synergies, and new growth opportunities.

Canada's top port seeks builder to add 70% capacity in Asia trade push

The Port of Vancouver is moving ahead as the country looks for ways reduce economic reliance on the U.S. The Port of Vancouver, Canada's main trade gateway to Asia, kicked off the search for a company to build a new wharf to handle 70 per cent more cargo, as the country looks for ways to reduce economic reliance on the United States. The Port of Vancouver said it already handles almost as much cargo as the next five largest Canadian ports combined. The work is expected to cost at least \$3 billion, Victor Pang, the port's chief financial officer, said. ### Container rates continue to drop

Drewry's World Container Index (WCI) continued its decline for the week of July 7-11, falling another five per cent to US\$2,672 per 40-ft container. Drewry indicated that the drop is a direct result of the low demand for U.S.-bound cargo and is a sign that the recent surge in U.S. imports, which occurred after the temporary halt on higher U.S. tariffs, will not have the lasting impact it had initially expected. Freight rates from Shanghai to Los Angeles decreased eight per cent to US\$2,931 per 40-ft container in the past week, but spot rates were also up eight per cent compared to nine weeks ago. Similarly, spot rates from Shanghai to New York dropped five per cent this past week to US\$4,839 per 40-ft container, but gained 33 per cent since May 8. Drewry expects spot rates to continue to decline next week as well due to excess capacity and weak demand. Freight rates from Shanghai to Genoa decreased seven per cent to US\$3,491 per 40-ft container, while those from Shanghai to Rotterdam fell two per cent to US\$3,384. Orient Overseas (International) Limited said it carried 4.4% more containers in the second quarter from the same period a year ago. The gain was generally in line with global container volumes for the quarter. The Hong Kong-based parent (0316.HK) of Orient Overseas Container Line, a unit of China's Cosco, said liner revenue fell 6.5% y/y to \$2.12 billion for the quarter ending June 30 as revenue per twenty foot equivalent unit slid 10.4%, from \$1,205 to \$1,079 per TEU. The largest decline was seen on Asia-Europe services, down 17.2%. Loadable capacity was 7.5% higher while the overall load factor fell by 2.4%. For the first six months ended June 30, 2025 liner revenue increased by 4.4% and total liftings increased by 6.8% y/y. The carrier's capacity was 8% higher, while the load factor fell 0.9%. # FMC probing service agreements between Port Houston, ocean carriers

The US Federal Maritime Commission (FMC) has launched an investigation into service agreements between Port Houston and major container lines that may require some carriers to deliver a percentage of loaded containers through the largest port along the US Gulf Coast. Houston is the fifth-busiest US container port and handled approximately 71% of laden volumes moving through the Gulf region last year, according to data from PIERS. The agency, in a filing made on July 11, 2025, ordered the port and carriers to provide information and data relating to what conditions caused carriers to agree to or refuse to sign terminal service agreements with Port Houston. The FMC's Bureau of Enforcement, Investigations and Compliance (BEIC) wants to know about previous agreements, including language on cargo commitments and details.

Port of Los Angeles: Busiest June in History

The Port of Los Angeles handled 892,340 Twenty-Foot Equivalent Units (TEUs) in June, an 8% increase from last year, marking the busiest June in the Port's 117-year history. Some importers are bringing in year-end holiday cargo now ahead of potential higher tariffs later in the year," said Port of Los Angeles Executive Director Gene Seroka. "July may be our peak season month as retailers and manufacturers bring orders in earlier than usual, then brace for trade uncertainty. June 2025 loaded imports came in at 470,450 TEUs, 10% more than last year. Loaded exports landed at 126,144 TEUs, a 3% improvement from 2024. The Port processed 295,746 empty container units, 7% more than last year. After six months in 2025, the Port of Los Angeles has handled 4,955,812TEUs, 5% more than the same period in 2024.

# Port of Corpus Christi customers close record second quarter, first half in Q2 2025

Port of Corpus Christi customers moved 51.1 million tons of commodities through the Corpus Christi Ship Channel in the second quarter of 2025. The tonnage marked a record second quarter for the Port, besting the prior second quarter record of 50.6 million tons, set in 2024. The first half of 2025 also proved the best first half in the history of the Port, with Port customers moving 102.4 million tons of commodities. The previous record first half saw 99.5 million tons transit the ship channel, in the first half of 2024. Crude oil shipments in H1 2025 totalled 65.2 million tons, up more than 3.8 percent over the

same period last year, while LNG volumes grew nearly 10.8 percent to 8.5 million tons. Additional increases occurred in dry bulk, breakbulk and other bulk liquids.

Dockworkers and terminal operators processed 704,403 twenty-foot equivalent units in June, down 16.4% from the same month last year. Imports declined 16.9% to 348,681 TEUs and exports dropped 10.9% to 87,627 TEUs. Empty containers moving through the Port decreased 17.4% to 268,095 TEUs. "We're anticipating a cargo surge in July as retailers stock up on goods ordered during the 90-day pause placed on tariffs and retaliatory tariffs," said Port of Long Beach CEO Mario Cordero. "The Port of Long Beach is prepared to handle the influx by tracking trade moving through the harbor with the Supply Chain Information Highway, our digital solution to maximize visibility and efficiency in cargo movement." "Over the long term, we're investing in infrastructure projects to keep cargo moving efficiently and sustainably to preserve our status as the Port of Choice." The Port has moved 4,746,631 TEUs through the first half of 2025, up 10.6% from the same period in 2024.

Port of Oakland June container volume declined, as shippers and carriers adjust to softening demand and ongoing tariff uncertainty. The Port handled 168,460 TEUs (twenty-foot containers), down 10.1% from May 2025, and 12.8% from June 2024, when 193,158 TEUs passed through Port facilities. Despite June's decline, year-to-date container volume remains higher than the same period last year. Total volume registered 1.14 million TEUs, marking a 0.6% increase over June 2024. Loaded imports were up 1.5%, while loaded exports experienced a 1.3% decrease. Loaded imports totaled 70,334 TEUs, marking a 11.3% decline from May, and a 16.3% drop from June 2024, when 84,040 TEUs transited Port facilities. Importers are responding to shifting trade policy and moderating consumer demand.

# Cargo theft surges 13% in Q2, organized crime targets high-value freight

Cargo theft incidents in the U.S. and Canada rose 13% year-over-year in the second quarter of 2025, with organized crime groups increasingly targeting high-value commodities, according to a news release from CargoNet, a Verisk Analytics company. CargoNet recorded 884 supply chain theft events between April and June, marking a 10% increase over the first quarter of 2025. The estimated total loss exceeded \$128 million when factoring in average shipment values for cases where specific losses were not reported. The average stolen shipment value reached \$203,586.

A trade deal with the United States will likely include some tariffs, Prime Minister Mark Carney indicated on July 15, 2025 ahead of a meeting with his cabinet. # Canadian transportation sector bracing for tariff fallout: KPMG

Canadian transportation companies are sounding the alarm over potential fallout from proposed U.S. tariffs, with rising operational costs, supply chain disruption and customer loss topping industry concerns, according to a new KPMG report. KPMG surveyed business leaders across the country and found that 77 per cent of transportation executives believe their companies will be directly impacted by U.S. trade actions. Half said they are extremely concerned about losing customers to American competitors, and a similar number flagged challenges with cross-border logistics. "Tariffs have a significant impact on the competitive landscape in transportation due to increased costs for domestic manufacturers who rely on imported materials," the report states. Price pressures were also flagged, with 62 per cent of transportation respondents extremely concerned about maintaining margins and 88 per cent expressing strong concerns about supply chain reliability.

### Transportation Consumer Price Index – June 2025

On July 15, 2025, the Bureau of Transportation Statistics (BTS) released the change in the costs faced by consumers for transportation goods and services, from June 2024 to June 2025, as measured by the Consumer Price Index (CPI). The annual change in CPI is a measure of inflation. The CPI for all transportation goods and services fell 0.1% from June 2024 to June 2025. Transportation contributed 0.3% to the 2.7% increase in the price of all goods and services, per the CPI. Motor vehicle insurance contributed the most to inflation, rising 6.1% year-over-year and contributing 6.4% to the annual change in the price of all goods and services. By item, the top three contributors to inflation in June 2025 were: Motor vehicle insurance: +6.4%; Used cars and trucks: +2.6%; and Motor vehicle maintenance and repair: +2.1%. The top three items dampening transportation's contribution to inflation in June 2025 were: Gasoline (all types): -11.0%; Airline Fare: -1.1%; and Other motor fuels: -0.2% Transportation Consumer Price Index – June 2025, July 15, 2025.



On July 16, 2025, the <u>Bureau of Transportation Statistics (BTS)</u> released the change in the costs faced by producers purchasing transportation services and industries producing them, from June 2024 to June 2025, as measured by the Producer Price Index (PPI). The PPI measures inflation from the perspective of costs to industry or producers of products. <u>Transportation equipment PPI</u> indicate the changes in transportation equipment prices faced by transportation providers, and any increase, increases providers costs. The PPI shows that prices increased for freight transportation and equipment 1.8% in June 2025 from June 2024. Increases in transportation services PPI indicate increases in production costs faced by industries purchasing the services. From June 2024 to June 2025, the <u>transportation services PPI</u> changed, by mode: 1. Air: +1.9%; 2. Rail: +2.1%; 3. Truck: +2.1%; 4. Water: -1.1%; 5. Arrangement of freight and cargo: +0.6%

# Roberts Bank Terminal 2 procurement underway, with Vancouver Fraser Port Authority issuing a request for qualifications for a construction team

The Vancouver Fraser Port Authority has started its search to find the best qualified team to progress construction planning and build the landmass and wharf component of the Roberts Bank Terminal 2 Project—a key milestone in advancing this nationally significant project.

Roberts Bank Terminal 2, a future state-of-the-art marine container terminal at the Port of Vancouver, will support Canada's trade diversification goals by unlocking over \$100 billion in new trade capacity and contributing \$3 billion in GDP annually.

"We're excited to issue the request for qualifications today and move this vital project forward. To meet Canada's needs in today's quickly evolving trade landscape, we have accelerated our efforts to deliver Roberts Bank Terminal 2—a project that will strengthen Canada's economic security and deliver trade resilience," said Victor Pang, CFO at the port authority. "The terminal will be a catalyst for economic transformation nationally—from supporting Prairie grain exports and B.C.'s forestry sector, to communities who depend on reliable and affordable access to essential goods on store shelves."

As part of a competitive selection process for the landmass and wharf component of the project, the port authority has selected a progressive design-build procurement with target price model. An independent fairness monitor has been appointed to oversee the fairness of the process.

The contract includes the delivery of an approximately 100-hectare marine landmass, 35-hectare widened causeway, 1,300-metre wharf structure and berth pocket, and expanded tug basin.

To support the port authority's award-winning environmental plan, the contract also includes the construction of a marine terminal fish passage to support juvenile salmon migration, and the civil works for onsite habitat enhancement and the South Arm Jetty Tidal Marsh Project—a priority project for First Nations to benefit fish and wildlife.

The request for qualifications marks the first step in the procurement process. Interested construction teams must provide an interim submission confirming their interest by September 18, 2025, and submit details of their qualifications by September 25, 2025. The port authority will shortlist three teams this fall, who will then be invited to submit a proposal.

The selected team will have extensive experience in collaboratively delivering major marine infrastructure projects with comparable technical, logistical, environmental and regulatory requirements, as well as a proven ability to deliver on First Nations' commitments.

A project information session will be held in Vancouver on July 22, 2025. To receive an invitation, interested construction teams should complete the receipt confirmation form and confidentiality agreement included in the request for qualifications.
