#### Flair Airlines Ltd. penalized for violations of the APPR

The Canadian Transportation Agency (CTA) has issued administrative monetary penalties totalling \$174,000 against Flair Airlines Ltd. for violations of the Air Passenger Protection Regulations (APPR). On or about August 17, 2024. Flair Airlines Ltd., committed 48 violations of subsection 18 (1.1) of the APPR by failing to provide passengers with the option of receiving a confirmed reservation for the next available flight that was operated by any carrier travelling on any reasonable air route from the airport at which passengers were located, or another airport that was within a reasonable distance of that airport, to the destination that was indicated on passengers' original ticket. On or about September 18, 2024, Flair Airlines Ltd., committed 24 violations of subsection 18.2 (2) of the APPR by failing to refund the unused portion of a ticket to passengers within 30 days after the day on which the carrier became obligated to do so. Flair Airlines Ltd., has until August 30, 2025, to request reviews before the Transportation Appeal Tribunal of Canada.

### Air Canada flight attendants vote in favour of strike mandate

Canada's biggest airline could face a strike if a deal not reached by Aug. 16, 2025. <u>Air Canada</u> flight attendants have voted to give their union a strike mandate. The Air Canada component of the <u>Canadian Union of Public Employees</u> says members voted 99.7 per cent in favour. The mandate does not mean that a strike is guaranteed, only that union members support the measure if the bargaining team decides to call for a work stoppage. The vote kicked off July 28 and finished earlier Tuesday, after the airline and union concluded the conciliation process without reaching a deal. The two sides have been in contract talks since the start of the year.

### Air Canada flight attendants to return to bargaining on Friday, union says

Air Canada flight attendants are heading back to the bargaining table with the airline on August 8, 2025, after overwhelmingly approving a strike mandate this week that could allow them to walk off the job as early as August 16, their union said on August 6, 2025. The Canadian Union of Public Employees, which represents more than 10,000 flight attendants at the country's largest carrier, would need to give 72 hours' notice before initiating any strike. Both sides have said they prefer resolving flight attendants' demands for higher pay through a negotiated settlement. Air Canada was not immediately available for comment. The Montreal-based carrier has said that there is enough time to reach a settlement and avert a possible strike.

# Air Canada Redefines How Members Earn Aeroplan Points and Achieve Aeroplan Elite Status

Effective for travel on or after January 1, 2026, Aeroplan members will earn points on eligible Air Canada flights based on dollars spent rather than the distance they travel. On the same date, Air Canada will introduce Status Qualifying Credits (SQC), a new single path for achieving Aeroplan Elite status, that will change how members qualify

for status based on their activities from January 1, 2026 onward. Members will be able to get SQC through eligible flight purchases, Aeroplan credit card spending, and activity with the program's travel and everyday partners. These changes are designed to better recognize Aeroplan members who spend more and travel more with Air Canada and who actively engage across the program, while keeping Aeroplan Elite status truly special. It will lead to new structure to earn points faster.

### Canada's Airlines and Airports Release Budget 2025 Recommendations

The National Airlines Council of Canada (NACC), representing Canada's largest air carriers (Air Canada, Air Transat, Jazz Aviation LP and WestJet), and the Canadian Airports Council (CAC), the voice of Canada's airports, on August 6, 2025, published their joint submission to the House of Commons Standing Committee on Finance's pre-budget consultation. NACC and the CAC are calling for the federal government to adopt the following recommendations for inclusion in Budget 2025 to enhance air travel in Canada: 1. Accelerate the adoption of a digitization strategy for air travel in Canada that is in line with digitized travel experience embraced in other countries. 2. Reduce regulatory burden to ensure regulations are modern, aligned with international standards and recommended practices, and leading to lower costs. 3. Include airport infrastructure in federal funding programs, including the National Trade Diversification Fund and Projects of National Significance. 4. Cap crown rent charged to airports at 2024 levels. 5. Reform Airport Zoning Regulations (AZR) and airspace protections, including noise, to address emerging challenges introduced by recent high-density residential developments in proximity to airports.

The International Air Transport Association (IATA) has released the latest edition of the <u>World Air Transport Statistics (WATS)</u> with comprehensive statistical data for 2024. Updated annually with data from over 240 international airlines, the WATS database provides a complete overview of airline metrics related to demand, supply, and performance. The report includes a detailed breakdown of scheduled passenger and cargo traffic demand, scheduled passenger and cargo capacity, overview of the global airline fleet, and top airport pairs. The report also provides details on the financial health of the industry with in-depth information on operating costs and revenue, aircraft utilization and number of airline employees.

#### BTS' New OD40 Program Takes Flight

On August 1, 2025, the <u>Bureau of Transportation Statistics</u> (BTS) officially launched the <u>Origin-Destination Survey of Airline Passengers</u> (<u>OD40</u>) <u>program</u>. OD40 is a major milestone for the BTS and the aviation industry, as the amount of origin-destination data will increase from a 10 percent sample of tickets collected quarterly from large carriers (OD10) to a 40 percent sample of tickets collected monthly from existing and new reporting carriers (OD40). Data collected includes the fare and itinerary of each sampled ticket. Today, airline carriers can begin <u>submitting data</u> under the expanded OD40 program. This expansion is based on a <u>final rule published in the Federal Register on January 31, 2023</u>, and will provide better data on travel that will inform airport planning and investments as well as other aspects of aviation policy.

# Trump's Transportation Secretary Sean P. Duffy Unveils Rule to Unleash American Drone Dominance as Part of His Innovation Agenda



On August 5, 2025, U.S. Transportation Secretary Sean P. Duffy unveiled a new proposed rule - Beyond Visual Line of Sight (BVLOS). This rule will unleash American innovation and safely integrate unmanned aircraft systems (UAS) into the national airspace system. The FAA's proposed rule for safely normalizing Beyond Visual Line of Sight (BVLOS) drone operations includes detailed requirements for operations, aircraft manufacturing, keeping drones safely separated from other aircraft, operational authorizations and responsibility, security, information reporting and record keeping. Previously, operators would have to get individual waivers or exemptions to use their drones without visual line of sight. These were approved on a case-by-case basis, and the process was cumbersome. By eliminating these requirements for BVLOS operations, the proposal will significantly expand the use-case for drone technologies in areas like: manufacturing, farming, energy production, filmmaking, and the movement of products including lifesaving medications.

# U.S. Airlines' June 2025 Aviation Fuel Consumption up 3.0% and Fuel Cost per Gallon up 0.2% from May 2025

The Department of Transportation's Bureau of Transportation Statistics (BTS) on August 5, 2025 released U.S. airlines' June 2025 fuel cost and consumption numbers indicating U.S. scheduled service airlines used 1.688 billion gallons of fuel, 3.0% more fuel than in May 2025 (1.639 billion gallons) and 0.4% more fuel than June 2024 (1.682 billion gallons). The cost per gallon of fuel in June 2025 (\$2.22) was up 0.4 cents (0.2%) from May 2025 (\$2.21) and down 32 cents (12.7%) from June 2024 (\$2.54). Total June 2025 fuel expenditure (\$3.74B) was up 3.2% from May 2025 (\$3.63B) and down 12.4% from June 2024

# CN Releases 2025–2026 Grain Plan: Strengthening Canada's Supply Chain

CN on July 31, 2025 published its 2025–2026 Grain Plan. The plan demonstrates CN's commitment to delivering high-performance service through disciplined planning, targeted infrastructure investments, and proactive supply chain collaboration. CN delivered a record volume of grain to both domestic and international markets this past crop year. Current projections suggest Western Canadian movement for 2024-25 will total approximately 31 MMT, roughly one million metric tonnes higher than the previous record. That figure includes bulk and processed grain by carload. Tracy Robinson, President and Chief Executive Officer, CN said "Our Grain Plan reflects CN's unwavering commitment to Canadian agriculture and the global competitiveness of our farmers and grain handlers. We've taken a comprehensive, end-toend view of the supply chain by investing where it matters most, collaborating with partners, and ensuring we have the people, equipment and processes in place to move the new crop."

NTSB Issues Preliminary Report for CN July 6

The National Transportation Safety Board (NTSB) has released a preliminary report for its ongoing investigation of the July 6, 2025, CN train derailment with hazardous materials release in Sardis, Miss. What Happened? The location where a Canadian National train derailed in Glendora, Miss., was under a 30-mph speed restriction following work to address track defects found by an autonomous track inspection vehicle, according to the National Transportation Safety Board's preliminary report on the July 5, 2025, incident issued today (Aug. 5, 2025). A tank car of benzene, among 22 cars that derailed, caught fire, forcing the evacuation of about 160 residents in a 1-mile radius. The derailment occurred about 2:26 p.m.; the evacuation order was lifted shortly after the fire was extinguished about 11:30 p.m. No injuries or fatalities were reported; CN estimated damages at about \$1.5 million. The train involved was en route from Memphis, Tenn., to Baton Rouge when it derailed at milepost 97.63 of CN's Yazoo Subdivision. Twentythree of its 139 cars carried hazardous materials. The train was traveling about 29 mph at the time of the derailment, which involved

cars 29 through 50. The CN track inspection device had recorded two superelevation defects in the derailment area on July 2. The track was resurfaced on July 3, with the next two trains operating under a 10-mph speed restriction through the site, after which the restriction was increased to 30 mph. That restriction was still in place. On-scene investigation by the NTSB included reviewing data from the lead locomotive's event recorder and inward- and outward-facing cameras, interviews, reviews of CN engineering standards and procedures, and inspection of train equipment. The ongoing investigation will focus on CN procedures relating to track inspections, mitigation of defects, employee training and testing, and emergency response.

**BNSF** earnings gain on lower costs

BNSF Railway reported pre-tax earnings increased 11.5% in the second quarter to \$2 billion from \$1.8 billion, and 8.6% to \$3.8 billion from \$3.5 billion in the first six months of 2025 compared to 2024. Operating revenues for the Fort Worth-based subsidiary of holding company Berkshire Hathaway increased slightly in both the second quarter and the first six months, to \$5.73 billion from \$5.71 billion and \$11.4 billion from \$11.3 billion year over year as lower operating costs offset weaker revenue per car, to \$3.7 billion from \$3.9 billion, and \$7.5 billion from \$7.8 billion. Net earnings climbed to \$1.5 billion from \$1.2 billion y/y in the 2025 second quarter, and to \$2.7 billion from \$2.4 billion in the first six months of the year. Freight volumes edge higher by 1.4% and 2.7% in the second quarter and first half, respectively, year over year.

### AAR: North American Rail Volume Up Through Week 31

North American carload and intermodal traffic for the first 31 weeks of 2025 (ending Aug. 2) was up 2.9% from the prior-year period, according to the Association of American Railroads' (AAR) latest rail traffic report. While the United States and Canada both saw gains, Mexico experienced a loss. North American rail volume for the week ending August 2, 2025, on 9 reporting U.S., Canadian and Mexican railroads totaled 337,571 carloads, up 4.5 percent compared with the same week last year, and 363,089 intermodal units, up 2.7 percent compared with last year. Total combined weekly rail traffic in North America was 700,660 carloads and intermodal units, up 3.6 percent. North American rail volume for the first 31 weeks of 2025 was 20,943,417 carloads and intermodal units, up 2.9 percent compared with 2024. Nine of the 10 carload commodity groups posted an increase compared with the same week in 2024. They included grain, up 4,402 carloads, to 21,557; coal, up 2,871 carloads, to 61,962; and motor vehicles and parts, up 1,467 carloads, to 15,822. One commodity group posted a decrease compared with the same week in 2024: petroleum and petroleum products, down 185 carloads, to 10,829. Canadian railroads reported 88,410 carloads for the week, down 2.2 percent, and 72,286 intermodal units, up 13.0 percent compared with the same week in 2024. For the first 31 weeks of 2025, Canadian railroads reported cumulative rail traffic volume of 5,035,654 carloads, containers and trailers, up 1.6 percent.

### Port of Los Angeles sees UP-NS merger as 'seamless transit' to East Coast

The proposed Union Pacific/Norfolk Southern rail merger could provide the Port of Los Angeles with "seamless transit by rail from Los Angeles to New York and other East Coast ...cities," according to Eugene Seroka, Executive Director, Port of Los Angeles. In an interview with AJOT, Seroka said that the proposed merger would provide Port customers with direct rail service to the East Coast that had not been possible before: "I think it gives us access to the most populous third of the nation that has otherwise been stitched together through handoffs." Seroka said the proposed merger will make the Port more competitive with East Coast ports: "Yes, we'll be more competitive to get cargo to the Eastern seaboard of the US for several reasons. Number one, you'll have one company that carries your cargo from LA to New York to Pittsburgh, Philadelphia, Norfolk, Baltimore, et cetera, all the way down the Eastern seaboard. Today, that cargo gets handed off in Northern Chicago ... from the UP to an East Coast railroad." Seroka argues, "So, we have got growth opportunities ... and the discretionary cargo that amounts to about a third of all the business we do has an easy way to ... get to the Midwestern locations. And now, opening up that Eastern Seaboard to us makes a more compelling argument for the Port of Los Angeles to grow its discretionary market of intermodal rail."

US shippers saved an average of 17% on spot market freight and nearly 24% on contract loads in the second quarter by using domestic intermodal instead of long-haul trucking with tepid pricing continuing through midyear, according to the latest *Journal of Commerce* Intermodal Savings Index (ISI). Intermodal contract rates were flat in the second quarter compared with a year ago — up less than 1% excluding fuel, but down less than 1% including fuel, while contract truckload rates rose between 0% and 2%.

# Canada eyes Arctic Ocean port to ship gas, commodities to Europe

The Canadian government is looking hard at developing a remote northern port on Hudson Bay as a conduit for exporting <u>natural gas</u>, potash, canola and other commodities as the country tries to reduce its economic dependence on the United States. Energy Minister <u>Tim Hodgson</u> said he sees "tremendous potential" for turning the port of Churchill, Man., into a much larger export hub, opening new trade routes to Europe and other markets. The minister said he has seen multiple pitches for projects to move goods through the location, which is at almost the same latitude as Oslo, Norway. "I believe there is an opportunity to make Churchill a far more strategic port," Hodgson said in an interview with Bloomberg News. "If you look at what the Russians are doing, they ship for most of the year from their Arctic ports." The idea of a northern port enjoys the enthusiastic backing of politicians from Canada's resource-rich western region, including Alberta Premier

# Update on construction timeline for the Port of Montreal Contrecœur expansion project

The Montreal Port Authority (MPA) has submitted its notice of intent to begin preliminary construction work for the Port of Montreal's Contrecœur expansion as early as September 29, 2025, pending receipt of the final required approvals. "This step allows us to meet the conditions required to move forward with a project that positions Quebec and Canada more strongly to diversify international trade," said Julie Gascon, President and CEO of the MPA. "Once all the necessary approvals are in place, we'll be ready to begin work on this major strategic project that is essential to the future of our supply chains." The initial work will focus primarily on preparing the project site for more significant construction activities which could take place, in 2026. All work remains contingent upon receiving the appropriate regulatory approvals. The full project timeline and a description of the planned activities are available on the Canadian Impact Assessment Registry website.

# Big US ports ask Congress to follow law for equal funding of dredging work

US port officials say they could be shortchanged about \$1 billion for dredging and maintenance projects because the current budget for the US Army Corps of Engineers does not follow through on a 2020 law aimed at more equal distribution of the fees importers pay for maintaining US harbors. In a letter sent on July 31, 2025 to a joint Congressional committee on energy and water, the American Association of Port Authorities (AAPA), along with the directors of 22 ports, said the Corps fiscal year 2025 budget allocation for dredging and other maintenance does not adhere to a provision of the Water Resources Development.

# Port of NY & NJ is the second-busiest U.S. port for loaded containers in the first half of 2025

The Port of New York and New Jersey continued to see strong growth over the first half of the year despite broad global uncertainty across the supply chain. The port handled 4,417,282 TEUs (twenty-foot equivalent units) during the first six months of the year. The total was a 4.9 percent increase over the same period of 2024 and a jump of 20.9 percent over pre-pandemic 2019. The port finished both the month of June and the full first half of the year as the second-busiest in the

country for loaded containers, handling 467,335 loaded TEUs in June and 2,945,962 loaded TEUs for the first half of the year.

#### Savannah containers post best FY since pandemic



The Georgia Ports Authority moved 5.7 million twenty foot equivalent container units (TEUs) in fiscal year 2025, an increase of 8.6% or 450,000 TEUs compared to the previous fiscal year. The fiscal period ending June 30 was the Port of Savannah's second-busiest year on record, after the pandemic year of FY2022, when GPA handled 5.76 million TEUs. "Georgia Ports continues to grow U.S. East Coast market share and with the shifting trade patterns in Asia and India, that bodes well for our future," said Griff Lynch, president and chief executive of Georgia Ports, in a release. Savannah's volume grew at a 4.5% compound annual growth rate for fiscal year-to-date compared to 2016, ahead of the 2.7% increase for the entire U.S. container port market. Savannah moved 410,400 TEUs in June as GPA terminals averaged more than 475,000 TEUs per month in the fiscal year. March, April and May each totaled more than 500,000 TEUs.

### Maersk boosts profit outlook as container demand defies trade fears

Maersk raised its full-year profit forecast on August 7, 2025 as robust global container demand defied fears that tariffs would hit trade, although the company predicted a slowdown later this year. Maersk, viewed as a barometer of world trade, said it now expected global container volumes to increase by 2% to 4% this year, compared with a range of down 1% to up 4% estimated in May. The new range implies lower second-half growth, it said. A drop in U.S. imports after President Donald Trump unleashed a barrage of tariffs on foreign goods "was more than offset" by strong growth in imports into other regions, including Europe, the Danish firm said in its second-quarter earnings statement. CEO Vincent Clerc told reporters that most customers - which include Walmart and Nike - are taking a wait-andsee approach to potential changes in their supply chains, and that container shipping was immune to trade tariffs in the short term. Chinese shipments into Europe and other regions started increasing last year and continued into 2025, Clerc said, adding that Maersk's own data did not suggest this growth was fuelled by U.S. tariffs.

#### Canada Post workers reject Canada Post's final offer

Canada Post Workers wrapped up Friday (August 1, 2025) on the Crown corporation's 'final' offer — a vote ordered by federal jobs minister Patty Hadju a month after a report declared Canada Post effectively insolvent. Canada Post workers have voted down the Crown corporation's "final" contract offer, and labour experts say it's unclear exactly what will happen next in the already bitter dispute. Members of the Canadian Union of Postal Workers' urban unit voted the offer down 68.5 per cent to 31.5, while members of their suburban and rural unit turned it down 69.4 per cent to 30.6. Just under 81 per cent of the 53,000 eligible CUPW members cast their ballot. The offer included a 13% percent increase over four years plus \$1000 signing bonus.

Unionized mail carriers at Canada Post have overwhelmingly voted to reject the company's latest contract offer, raising questions about the potential for a strike or lockout that could further undermine delivery service and whether the government considers the troubled

organization too big to fail. The result was expected by some experts who said front-line workers feel they have the upper hand because Canada Post is state-owned and has a universal service obligation. "The union believes, probably correctly, that at least for the foreseeable future, the government will continue to backstop any losses, so why would you take that offer?" said Eric Miller, president of cross-border government relations consultancy Rideau Potomac Strategy Group and a former industrial policy official in the Canadian government. Left unresolved is the core issue of how to run a universal mail service in an age of highly capable private carriers that are taking a bigger share of the nearly \$17 billion Canadian parcel market. The government-owned postal operator is looking to a new labor deal as the permission structure for modernizing an outdated business model, with the goal of turning around its finances and improving service for residents and businesses.

Labour experts say another postal service strike is unlikely. So what happens next? Adam King, assistant professor in the labour studies program at the University of Manitoba, said the forced ratification vote ordered by the federal government and administered by the Canada Industrial Relations Board was a "distraction." "Hopefully, at the end of the day, we see an agreement reached at the table — where it should have been in the beginning," he said in an interview. "Canada Post management is really going to have to put something on the table that the union actually thinks members will accept."

The Ontario Trucking Association (OTA) is calling on Premier Ford and his cabinet to increase resources to the Ministry of Transportation (MTO), the Ontario Provincial Police (OPP) and other agencies to expand enforcement efforts through <u>Operation Deterrence</u>. OTA's call comes in response to US President <u>Trump's announcement to increase tariffs to 35 percent</u> on non-CUSMA qualifying goods due to ongoing concerns over drug trafficking and immigration issues at the northern border.

# Canada and Ontario Invest in Public Transit Infrastructure for North Bay Residents

North Bay is gearing up for more sustainable and convenient transit thanks to a combined investment of over \$20.6 million from the federal and provincial governments and the City of North Bay. Announced on August 6, 2025 by MP Pauline Rochefort, MPP Vic Fedeli and Mayor Peter Chirico, this funding will make transit safer and easier while cutting down on carbon emissions. The investment will replace eight conventional buses with hybrid buses in the North Bay Transit fleet and support new sidewalks and stormwater system upgrades. The city will also use these funds to upgrade a transit terminal and the fare collection system. Investments in public transit help Canadians get where they need to be, create new manufacturing and construction jobs, reduce pollution and make life more affordable.

#### New US de minimis policy could trim DHL profit by 3%

DHL express shipments fell sharply when the U.S. government recently eliminated a waiver on duties and fees for small-dollar shipments arriving from China and Hong Kong. Applying the new rule worldwide at the end of August could reduce projected full-year operating profit by \$231 million, the company's chief financial officer said on August 5, 2025. DHL Group increased profits during the second quarter, despite a rise in protectionism and fighting in the Middle East that lowered shipment volume, by successfully eliminating structural costs and improving yield management. The integrated parcel logistics giant reported second quarter revenue decreased 3.9% to \$22.9 billion, but operating profit grew 5.7% to \$1.6 billion with profit margins improving 0.7 of a point to 7.2%. Slower trade activity and negative effects of exchange rates diminished results.

In June 2025, Canada's merchandise imports were up 1.4%, while exports increased 0.9%. As a result, Canada's merchandise trade deficit with the world widened from \$5.5 billion in May to \$5.9 billion in June. Exports to the United States increased 3.1% in June. However, on a vear-over-year basis, exports to the United States were 12.5% lower compared with June 2024.

Canada's monthly international trade in services deficit narrowed from \$0.9 billion in May 2025 to \$0.7 billion in June. Overall, imports of services edged down 0.2% to \$18.7 billion, and exports of services rose 1.0% to \$18.0 billion. Imports of travel services fell 0.8% to \$4.5 billion in June 2025, while imports of transportation services increased 1.1% to \$3.2 billion. Imports of commercial services fell 0.3% to \$10.8 billion, led by a decrease in financial services. Exports of commercial services increased 1.2% to \$10.8 billion in June, mostly due to an increase in non-financial commercial services. Exports of travel services also increased 1.2%, reaching \$5.2 billion. Exports of transportation services edged down 0.3% to \$1.9 billion.

The unemployment rate in the U.S. transportation sector was 4.3% (not seasonally adjusted) in July 2025, according to the Bureau of Labor Statistics (BLS). These data have been updated on the Bureau of Transportation Statistics' (BTS) <u>Unemployment in Transportation dashboard</u>. In July 2025, the transportation sector's unemployment rate fell 1.4 percentage points from 5.7% in July 2024, but was just above the pre-pandemic July 2019 level of 4.2%. Unemployment in the transportation sector reached its highest level during the COVID-19 pandemic (15.7%) in May 2020 and July 2020. Unemployment in the transportation sector was lower than the overall unemployment rate. BLS reports that the U.S. unemployment rate, not seasonally adjusted, in July 2025 was 4.6% or 0.3 percentage points above the transportation sector rate. Seasonally adjusted, the U.S. unemployment rate in July 2025 was 4.2%.

U.S. Transportation Secretary Sean P. Duffy on August 5, 2025 announced a loan of up to \$3.89 billion from the Build America Bureau to a public-private partnership between the Georgia Department of

#### Cultivating Intelligence: How Generative AI Reimagines Agricultural Supply Chains by Dileep Rai, CMILT

#### Introduction

Agricultural supply chains have traditionally relied on intuition, experience, and traditional methods. However, in a world with expanding global markets, unpredictable weather, and fluctuating commodity prices, these old approaches are no longer enough. These systems face increasing pressure to become more efficient, transparent, and adaptable.

Even with data-focused strategies and automation, critical supply chain choices in agriculture still take hours or days of human analysis, simulation, and manual updates. Now, a shift is happening, fueled by large language models (LLMs) and generative Al. These models transform labor-intensive workflows into intelligent conversations, drastically reducing planning times from weeks to minutes.

This article examines how LLMs are transforming agricultural supply chains by using a fictional yet illustrative Agri-tech company as a case study. Their pilot deployment of Al across farming operations, processing facilities, and distribution centers shows both the potential and the hurdles of this technology.

### Al-Driven Transformation of Agricultural Supply Chains



#### 1. Data Discovery and Insights

This Agri-tech company operates a network of farms that produce a diverse range of crops, including corn, soybeans, and vegetables. Traditionally, key operational questions are buried in spreadsheets, ERP dashboards, or isolated databases. For example:

- "How much corn feedstock is available at Farm B?"
- "Which storage unit showed the highest spoilage last month?"
- "What's the cheapest route to move produce from Farm C to Distribution Center 4?"

Through LLM integration with their data warehouse, planners now retrieve answers in natural language. A query results in:

Farm B currently has 18,200 bushels of yellow corn. The best shipping route to DC 4 is Farm C  $\rightarrow$  DC 2  $\rightarrow$  DC 4 at \$220 per ton.

This not only democratizes data access throughout the organization but also preserves data sovereignty by hosting LLMs on secure, inhouse cloud infrastructure.

#### **Trend Visibility and Operational Context**


The system doesn't just answer questions, it detects trends. LLM-generated daily briefings alert stakeholders to:

- Regions at risk of weather-induced delays
- · Weekly shifts in production volume
- Sudden rises in storage or shipping costs

This replaces hours of report mining with proactive, insight-rich communication.

#### 2. What-If Scenario Planning

LLMs enable planners to ask nuanced hypothetical questions without needing to adjust optimization tools manually. Some examples:

"What happens if corn demand increases by 20% in Q3?"

- "Can we meet current targets if Processing Plant D closes for a week?"
- "What are the cost implications of switching to organic fertilizer from Supplier X?"

The LLM tweaks the underlying supply model and simulates outcomes:

"A 20% spike in demand will drive transportation costs up by 8%, and trigger a 95% utilization threshold at DCs. Recommend leasing additional cold storage units."

Where earlier such analyses took teams several days to develop and review, they now occur in less than ten minutes, allowing for proactive and confident decision-making.

#### How to respond to hypothetical scenarios? **Plant Closure** Increase Corn Demand Meet targets with current resources, no Transportation costs immediate action rise by 8%, needed. recommend leasing cold storage. Switch to Organic **Fertilizer** Cost implications need further analysis, no immediate recommendation. Made with 🭃 Napkin

#### 3. Real-Time Interactive Planning

In agriculture, disruptions are inevitable. A heatwave, labor strike, or flood can paralyze logistics overnight. Without generative AI,

replanning required manual recalculations, inter-departmental coordination, and delay-prone model updates.

With the LLM embedded in their planning system, planners issue a command:


"Re-plan all outbound shipments assuming Plant D is offline from April 5 to April 10."

The model updates delivery schedules, redistributes load to alternate facilities, and summarizes:

"70% of demand fulfilled via rerouting to DC 3 with an estimated \$45K increase in cost. 15% of shipments projected to be delayed by 2 days."

Mitigation actions, such as cross-regional inventory pooling, expedited shipping, or external sourcing, are recommended immediately. What was once a fire drill becomes a calm, analytical conversation.

#### 4. Best Practices for Adoption

Success with LLMs is grounded in a structured adoption framework with four pillars:

#### a. Precision in Language

The efficacy of LLMs hinges on clarity. Ambiguous queries, such as "optimize distribution," are replaced with specific ones, such as

"Minimize transport cost while maintaining freshness under 36 hours." The company codified supported queries and provided training to ensure consistent input quality.

#### b. Validation and Guardrails

To prevent errors or hallucinated outputs, the model is domaintrained and governed by fallback logic. Unsupported queries are met with prompts such as:

"That scenario is not within current parameters. Please choose from the recommended templates."

Each plan generated by the LLM is cross-verified against KPIs and subjected to manual oversight before execution.

#### c. Evolving Workforce Roles

Planners now focus on strategic scenario evaluation and supplier collaboration. The LLM identifies anomalies such as:

"Supplier Y crossed the rebate threshold of 10,000 units, unlocking a 5% volume discount."

Such intelligence, previously uncovered only in quarterly reviews, is now immediate.

#### d. Cross-Functional Alignment

Previously siloed departments now co-plan in real time. For example, marketing can test a flash promotion by asking:

"What is the logistics impact of a 10% sales lift for Midwest tomatoes next week?"

The LLM evaluates and proposes adjustments across supply, transport, and labor, fostering a culture of synchronized execution.

#### 5. Challenges and Opportunities

Adopting generative AI in agriculture is not without friction:

**Model Transparency:** Al-generated outputs need clear audit trails. This company is developing versioned "model diffs" to track changes in assumptions.

**Scalability**: Rare events (e.g., sudden pest outbreaks or trade bans) demand continual template expansion.

**Data Readiness:** Farm-level IoT sensors, climate data feeds, and yield estimates must be integrated and validated in real time.

**Training Culture**: New hires undergo monthly simulations to stay aligned with evolving LLM capabilities.

#### 6. Vision: Closed-Loop, Cognitive Farming

The next frontier is fully autonomous, closed-loop planning:

#### **Problem Framing:**

"Allocate 80K acres across crops to optimize profit, fulfill demand, and maintain storage above 90% fill."

#### **AI-Driven Optimization:**

The LLM incorporates live data on soil, labor, forecasts, and costs to generate:

"Plant 40K acres of corn in Region A and 25K of soy in Region B. Net profit: \$3.2M. Allocate 120K gallons of fertilizer."

#### Live Plan Recalibration:

As weather, labor, or market conditions shift, plans update autonomously.

Such cognitive models will dissolve the traditional lag between data visibility and action, making agricultural supply chains as adaptive as the natural systems they depend on.

#### About the job:

Logistics Generalist - Senior Duties include adhering to the regulations/guidelines/SOPs of the Office of Logistics and the Sponsor's logistics and supply chain regulations, close coordination with senior Logistics staff officer (or their designated representative) in the appropriate Directorate/Mission Center/Component/Office of assignment, assisting with the administration and control for the purchase of materials and services; directing the complete process for transporting people and goods; overseeing materials management within area of assignment; coordinating and planning facility services; tracking cost issues and personnel resources; and administering elements of multi-faceted programs. Logistics Generalists could potentially travel to CONUS or OCONUS locations in support of temporary logistics requirements of the Directorate/Mission Center/Component/Office of assignment.

#### **Duties/Tasks and Responsibilities:**

- The Senior Logistics Generalist contractor is required to possess a highly diverse and experienced skill set regarding logistics operations. The duties/tasks and responsibilities described below are dependent on the office of assignment and subject to the priorities set by the senior Logistics staff Officer with purview over logistics operations where the Logistics Support Generalist is assigned. Duties tasks and responsibilities described below are dependent on the office of assignment.
- Assists with purchasing of materials and services within area of assignment to include:
- Assisting with the ordering of materials through a variety of internal and external sources; validating customer requirements against regulations and estimates costs.
- Reconciling routine to moderately complex financial statements to ensure expenses are properly recorded;

- reconciling accounts payable to ensure accuracy and funding availability; and reviewing bills/invoices for accuracy.
- Assists in the coordination and transportation of material and people.
- Coordinates transportation processing by completing proper transportation documentation; learns how to ship and receive material; and assists in arranging transportation of material.
- Arranges for appropriate stock levels of packing material /boxes/tape material for shipment of equipment (sometimes fragile equipment).
- Prepares material for shipment to include safe-handling and packaging for shipment in accordance with Sponsor standards.
- Arranges for courier and/or chauffeur services by coordinating with appropriate transportation office.
- In coordination with the appropriate component/mission support staff/or senior Logistics staff Officer, the contractor will research best transportation options for customers and determine best shipping methods based on customer, cargo type, and/or consignee timeline requirements.
- Obtain approval in advance from the appropriate Logistics
  Directorate/Mission Center/Component/Office staff officer (or
  their designated focal point) for any freight/aviation and
  aviation planning requirements (large or small) that require
  coordination with the Sponsor's Transportation Fusion Center
  or any other entity involved in arranging aircraft scheduling.
- Responds to courier and chauffeur requests; resolves scheduling problems.
- Maintain inventories of goods and materials in accordance with this organization's regulations.
- Processes inventory requests and validates receipt of goods and materials against requirements; ensures inventory requests are fulfilled.
- Coordinates the maintenance of a fleet of vehicles by maintaining table of vehicular allowances and tracking database; ensures vehicles are maintained.
- Where required, serves as the Responsible Officer of record.
- Coordinate with Sponsor's Facilities Management in the implementation of office moves, renovations, and maintenance.
- Implements office moves; establishes schedules and procedures; ensures proper number of staff are available.
- Assists Facilities Management in office renovations by serving as a liaison to customers and construction workers.
- Schedules routine office maintenance; works with Facilities Management to ensure offices are properly maintained.

- At any location: Coordinates with Facilities Management and IT Support to facilitate any computer movement, connections, and phone service.
- Other duties as assigned.
